

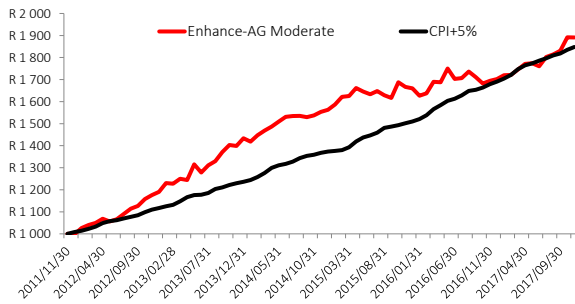
Fund Objective and Investment Strategy

The investment objective of the Enhance – AG Moderate Fund is to achieve capital growth by investing in South African and international asset classes within the prudential investment guidelines set out in Regulation 28 of the Pension Funds Act. The portfolio aims to outperform CPI + 5% per annum over rolling 5-year periods. The portfolio has a higher risk profile and a longer-term investment horizon.

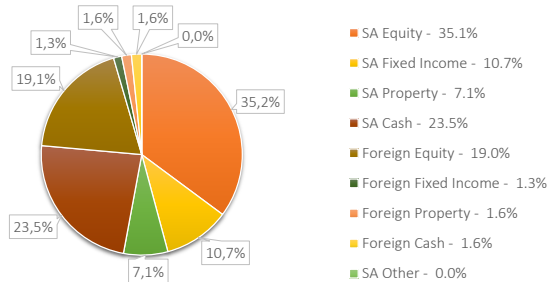
