

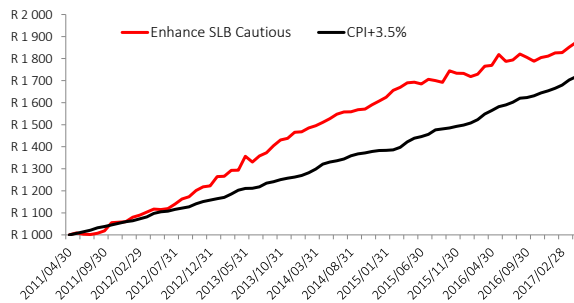
### Fund Objective and Investment Strategy

The investment objective of the Enhance – SLB Cautious Fund is to achieve capital growth by investing in South African and international asset classes within the prudential investment guidelines set out in Regulation 28 of the Pension Funds Act. The portfolio aims to outperform CPI + 3.5% per annum over rolling 3-year periods. The portfolio is aimed at moderate investors with a medium-term investment horizon.

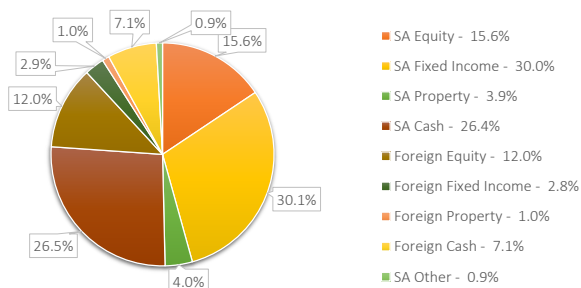
