

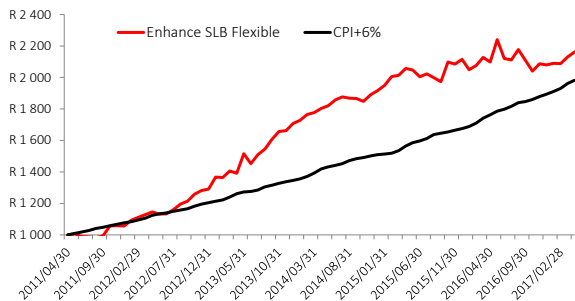
**Fund Objective and Investment Strategy**

The primary investment objective of the Enhance – SLB Flexible Fund is to maximize investment capital, accepting the higher level of risk associated with this strategy. The strategy will invest in South African and international asset classes and will not be within the limitations set out in Regulation 28 of the Pension Funds Act. The objective of the portfolio is to produce a return in excess of CPI + 6% over any rolling 5-year period.

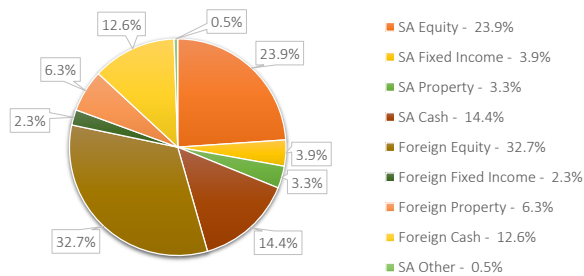
